

Building the Future...Now!

Making the Case for a New Comprehensive Career-Technical High School in Upshur County, West Virginia

What makes a student succeed?

An obvious reply is to ask for a definition of "success." Today, *success* means different things to different people. For some, it simply equates to employability after high school. For others, it is entry into a prestigious field of choice. Still others chase a more spiritual path and define success by the presence of strong, potentially lifelong relationships. The world is changing quickly. We want to be sure that Upshur county students are ready for the future. The knowledge and skills needed to succeed 20 years ago are different from those needed today.

Upshur county convened a group of educators, businesspeople, parents, and students to examine the today's job environment and create a portrait of a well-prepared, life-ready, Upshur County High School Graduate. Stakeholders shared their desire for our graduates too be ready with world class knowledge, including reading and math, essential knowledge of the arts, social studies, stem, and world languages. They also want students to have a deep understanding of career awareness and financial literacy. Desirable skills also include life characteristics such as ready to learn, fail and improve. Being flexible and adaptable, self-aware and confident are important skills as well.

The potential employer requires our graduates to be inclusive and have an open- minded attitude. They are looking for a strong work ethic, perseverance and grit. They want their employees to be civically engaged and practice habits of wellness. And finally, the college and career skills necessary to create a path of success for our Upshur County students will include verbal and nonverbal communication, teamwork and collaboration, innovative problem solving and creativity, organization and self-direction.

The job of the educator is to impart wisdom and to nurture success, and to do that, connect with students at unique points on the spectrum of their definitions of success.

Career and Technical Education

"Career and technical education (CTE) provides an opportunity pathway to success for high school students and offers each student opportunities to personalize his or her education based on their interests and unique learning needs" (USDE, 2019). As new technologies birth new careers and a relentless pursuit of innovation sets new workforce expectations, the demand for new skills opens doors to new definitions of success. Further, today's children have grown up with choices, from entertainment to the modes of delivery for their education. Thus, they expect to have options available that align with their budding career interests. Educators and education districts, therefore, must be ready with as many pathways as possible.

Rural education faces a dilemma: where is the balance between traditional, college-bound programs and CTE programs?

Employment requiring only a high school diploma remains, as do positions that require an undergraduate degree or higher. Education pathways toward those opportunities are important and necessary. As the U.S. Department of Education notes, however, there is a workforce skills gap for positions requiring "middle skills," those that require *either* a diploma, post-secondary certificate, or associate degree. In 2019, there were 30 million jobs in the United States with a median pay of \$55,000+ that *did not* require a bachelor's degree. There were not enough qualified (per education) candidates to fill those positions. CTE opportunities at the high school level, that either lead to additional study, apprenticeships, certificates, or employment can be a way to bridge that gap.

Anecdotally, then, one would expect to see an increase in CTE course credits earned by high school students. Available data tells a different story. "The percentage of graduates earning CTE credits declined from 95 percent in 1992 to 88 percent in 2013" (Liu & Burns, 2020, p. 4). The Liu and Burns study found no statistically significant differences in gender or other personal characteristics between, nor did their study find measurable differences in achievement between those that pursue CTE credits and those that do not. The study noted changes in the number of credits public school graduates receive in various subjects. For instance, average credits in enrichment, mathematics, and science areas have increased, while English and fine arts have remained largely the same.

Liu and Burns' study also reported the change in the average number of CTE credits obtained. Traditional trades, like construction, mechanical, and business/marketing have declined, while public services, healthcare, agricultural (and natural resources), and computer and information science have increased (2020, p. 7). The authors' study utilized 2013 data, and the trades showing the gains loosely correspond to more recent, sustained gains in similar sectors across the nation's economy.

Trends related to subject matter within CTE aligning with economic trends is not surprising. Reconciling decreases in CTE enrollment against what appear to be higher demands for the skills imparted by CTE education requires more recent data (what are the trends from 2013 through 2020, for instance), data on access to CTE programs, and data regarding interest in CTE graduates. The U.S. Department of education reported that 98% of public-school districts offered CTE options to students, with varied access to the programs, ranging from options in regular high schools in the same district (when districts offered programs) (83%), part-time CTE centers (43%), at a community or four-year college (35%), online (30%), at a CTE-focused high school (12%), and at regular high schools in a different district (11%). Thus, a lack of access does not appear to be the major problem.

Employer interest in CTE graduates appears to be increasing. Applied Education Systems (AES) reports that 11 of the 20 fastest-growing jobs are in the healthcare field. Healthcare careers will grow 18% between 2016 and 2026. Further, AES (2019) projects 194,500 new jobs in STEM areas, 634,400 in transportation and logistics, and 773,800 in business between 2016 and 2026. Flexibility appears to be key; trends within CTE education suggest alignment with economic trends (and opportunities), and anecdotal data suggests that with an increased pace of innovation, the nation may be in need of more capable, technically savvy, and adaptable graduates.

Gen Z and Beyond

Generation Z, those born between 1996 and 2010 (McNeil, 2018), are the first true "digital natives" (Francis & Hoefel, 2018). McKinsey & Company studied their preferences and influence on consumer industries and identified four core behaviors: (a) valuing individual expression and avoiding labels, (b) mobilization for a variety of causes, (c) belief in the efficacy of dialog as a component of conflict resolution, and (d) analytic and pragmatic decision-making (Francis & Hoefel, 2018). The article's primary take-away was that "Businesses must rethink how they delivery value to the consumer," (para. 4).

Other researchers have studied Gen Z's learning preferences. Nicholas (2020) found a preference for digital resources in education as well as in-class, hands-on work. The Association for Career & Technical Education (2020) says that "Experiential learning is key." Gen Z students look for the connections between their class activities and the real world. These students seek out collaborative, social learning opportunities (Panopto, 2020). Further, early research on Gen Z suggests that it could be the best-educated generation the U.S. has yet seen (Parker & Igielnik, 2020).

Though it is difficult to predict how one generation will differ from the next, Gen Z carries forward values-based trends from the Millennial generation. As Millennials and Gen Z ages with families, they may impart these values on their children, thus strengthening the focus for future generations. Thanks to digital marketing and other technological evolutions, members of Generation Z had even more customized options at their disposal than the Millennials (who, in turn, had more customization available than previous generations). These trends may continue. Further, employment will likely become more specialized, thus creating the need for more technical and flexible options as the rate of technological innovation remains the same or increases.

The Case of Upshur County, West Virginia

Community Background

Within this changing landscape, Upshur County, West Virginia sits at an interesting crossroads. The needs of the workforce are changing, and that applies to every community in the United States. Yet West Virginia has recorded the largest out-migration (by percentage) of any state according to initial Census 2020 estimates (Raby, 2021). Decisions made about education and opportunities are important and have everyone's attention.

Upshur County consists of one city and several smaller communities. Buckhannon, the county seat, is located on the north end of the county while Rock Cave is at the south end of the county. The community of Tallmansville is located near the center of the county. Thanks to US Route 33 (Corridor H) and Interstate 79, Upshur County is a short drive from all the amenities offered in nearby Clarksburg, Bridgeport and Morgantown, WV, as well as Pittsburgh or Charleston.

Though there has been fluctuation in Upshur County's population, it has remained largely consistent since 2010. Upshur County's population has remained between 22,000 and 25,000 for several Census cycles; local leaders anticipate that the population will remain steady (in the 2020 Census) despite state trends based on historical and observational data. Development in Upshur

County may support a steady population, though a project resulting in a population "boom" is unanticipated.

Population change often relates to economic drivers, both in the county and the region. Locally, oil and gas production and pipeline construction have slowed as compared to estimates from previous years. West Virginia Wesleyan College in Buckhannon has largely avoided the sustainability issues that many small, private colleges face, though its personnel roster is also slightly down.

As noted above, the Millennial and Gen Z generations have different outlooks on employment than previous generations. Younger members of the workforce often look for a variety of opportunities. They appear eager to experience life in several positions and communities before settling down, whereas previous generations looked for places to remain long-term earlier in their careers. Further, younger workers will often accept less pay in exchange for non-traditional benefits packages like flexible schedules. For employers, it is as much about offering an experience as it is a job. Fortunately, diversity appears to be on the rise in Upshur County, and this diversity has had impacts on the services offered in Upshur County's schools. Community officials noted an increase in the number of English as a second language (ESL) residents. Census data, though, still notes low percentages of minority populations. School officials also noted an increase in home schooling throughout Upshur County. The community has also seen a new range of functional and access needs somewhat attributable to the opioid epidemic. For instance, variation in social factors such as children living with grandparents or in foster care has led to a need to understand a wider range of psychological issues. School officials continue to look at expansion of its PALS program (at all levels: elementary, middle, and high) and the associated facilities needs that accompany that expansion. Upshur County experiences a great economic diversity, which includes a mindset of generational poverty in some communities (Upshur County Schools, 2020).

Various community groups in Upshur County work well together, and they often employ a problem-solving approach. In other words, immigration, migration, and travel offer two-way benefits. They do not represent downward population trends. The Clarksburg-Bridgeport area approximately 30 minutes to the north of the Buckhannon area are growing economically. Portions of Upshur County could take advantage of residential development as people move into the wider region to work in Harrison County and points north. Should this development occur, census trends in Upshur County's schools would change.

Fostering Innovation

Upshur County Schools made a bold commitment to elevate and diversify its educational approach and prepare students differently for the workforce they will enter by placing greater emphasis on innovation, critical thinking skills, and advanced career-based programs. To achieve this feat, the district partnered with the West Virginia Department of Education and local business and industry to become a "Dreamer District."

Upshur County Schools supports innovation throughout all grade levels of its schools, starting with a new approach to learning. Schools across the county are using a focus on enhanced career-based programs for students to explore, experiment, and celebrate pathways of learning in

preparation for college and career. Ninth through 12th grades have programs at Buckhannon-Upshur High School that delve into career development such as business/marketing, culinary/hospitality, and teacher preparation. But our community demands and deserves more opportunities for our students and preparation of our graduates to be fully employable upon graduation, and increased opportunities for adult learners to improve their employment and economic standing, as well. These additional program strands will not only complement and but also extend current CTE programs within the existing Fred Eberle Technical Center, which is a tri-county facility serving Upshur, Lewis, and Barbour Counties.

Building the Future...Now

Today's students need hands-on learning opportunities in a simulated workplace environment that allow them to develop critical thinking and problem-solving skills which they will use in future careers. Our plan is to develop a campus with a new, 120,000 square-foot comprehensive career-technical facility that expands college and career preparatory opportunities currently available to 11th and 12th grade students and places greater emphasis on science, technology, engineering, the arts and mathematics (STEAM).

This innovative campus will support learners at all levels. Students who plan to attend college can take dual enrollment courses to earn credit toward their college degree, with the goal of those college bound students attaining an associate degree upon graduation. This will be a facility that will inspire learning and prepare graduates for vocations yet to be identified and build capacity in entrepreneurial skills.

Graduates who prefer to enter the workforce or military immediately can learn skills or trades that help prepare them for their careers. Students who have not decided on a career path, meanwhile, can further explore interests and build skill sets that will give them a competitive advantage as they enter the workforce. Students will have opportunities for off-site internships and apprenticeships for hands-on experience in a variety of potential career fields. We have come to understand a critical tenet in education is that there is no longer one path to success; there are now multiple pathways that enable students to evolve into the entrepreneurs of tomorrow.

Our proposed school will provide a flexible and adaptable environment that will evolve as future careers and the demands of the West Virginia workforce evolves.

The proposed facility will create various learning environments and social spaces, moving away from traditional classrooms for instruction to lab environments that provide science, technology, engineering, the arts, and mathematics (STEAM) opportunities and hands-on areas for project-based curricula. By collaborating with industry partners, the district and designers will be able to better understand the goals and needs of each career pathway and ensure critical design parameters such as special space requirements with access, loading on the floor, furniture and fixtures, and equipment needs were appropriately defined. Industry-specific spaces support real-world training or trade certification programs and learning studios/laboratories will provide flexible learning spaces for experimentation and exploration, with some with direct access to sheltered outdoor work areas. A large commons area in the center of the school will be the highlight of the facility. This will serve as the heart of the campus and will be a place for

intentional synergy between interdisciplinary interactions, industry partners, and specific programs. Additionally, the facility will contain flex spaces to promote strategic interaction and encourage collaboration.

Through Upshur County's Comprehensive Educational Facilities Plan (CEFP), which is completed every ten years, district officials collected information from our community. Upshur County citizens reported that they want to build a new high school rather than a new middle school. To support this vision, Upshur County Schools will move the middle school students to its current high school facility and improve the space by adding up-to-date career technical programming. The new CTE high school will offer a new hope and future for our community as $% \left(1\right) =\left(1\right) \left(1$ we focus on programming that will provide stackable credentials, internships, apprenticeships and career training to our high school students and adult learners. This high school will offer programs to students during the day and adult programming and certifications during the night. It could serve the entire North Central West Virginia area.

The Request

The economy is changing, and workers need to be adaptable. This school, from its design to the curricula it delivers, must be equally adaptable. Yet, this vision does not come without a price tag. Upshur County Schools seeks support from a variety of sources, including those at local, state, and national levels; those in the public and private sector; to generate \$64 million to make this dream a reality.

B.3 Myrna Street Residents - Jawbone Run Storm Sewer Issues - Mayor Skinner recognized the residents from Myrna and Boggess streets to speak about flooding issues having to do with the Jawbone Run area. Bonnie Krum started off the discussion and was joined by David Krum, Helen (Sue) Boring, Bill Beathe, and Mike & Rose Whitehair, who have all had issues with flooding. Representatives from the City who were on hand to discuss the engineering aspects of the situation were the Director of Public Works Jerry Arnold, City Engineer Jay Hollen, and Sanitary Department Superintendent Ethan Crosten. Mr. Arnold reported that they have inspected the area and found no blockages in our storm water drains. What they did find were property maintenance issues in areas where the City has no right of ways and areas where equipment could not be used. Jay Hollen provided specifics on four locations of debris fill that is collecting and potentially creating issues with the main area seeming to be at the 18 Myrna Street property. Discussion on the various reasons for flooding in this area of town as well as other areas of the City took place. It was explained that property owners have the responsibility to maintain the riverbanks and river beds that are a part of their property, to assure the water flow is consistent. The Mayor wants our current ordinances explored to see if there is any language that could help enforce this or if a new ordinance needs to be created. The City cannot do the maintenance on any of the properties as they are privately owned. Mayor Skinner will see if a volunteer group can be assembled to do some of the cleanup necessary in the interim.

The firm that was selected and is being recommended to Council is Potesta & Associates,

Help Desk Support Specialist: Job Description

Help desk support specialist will provide technical assistance and support related to computer systems, hardware, and software. The specialist will be responsible for answering queries and addressing system and user issues in a timely and professional manner. The purpose of this letter agreement ("Agreement") is to memorialize the terms by which West Virginia Wesleyan College ("WVWC") will lease space from the City of Buckhannon ("City") at the City's former public works facility located at 16 Factory Street, Buckhannon, West Virginia ("Facility"). The City of Buckhannon is pleased to be able to offer the use of some of its space at the Factory Street facility to West Virginia Wesleyan College to assist the college in its loss of physical plant space located on College Avenue, Buckhannon. The terms of this Agreement, which may be modified upon further agreement of the parties, are:

- The Agreement will be deemed effective September 1, 2021 and will expire at the close of business on March 31, 2022 unless extended in writing by the parties jointly. This Agreement shall not be construed to permit occupancy of the Facility past August 31, 2022 absent further written agreement of the parties.
- 2) WVWC will pay to the City the sum of One Thousand Dollars (\$1,000.00) per month, on the first day of each month (beginning on or about September 1, 2021) during the initial or extended term of this Agreement.
- 3) WVWC will limit its use the Facility to the operations of its Physical Plant staff and equipment; Jerry Arnold, City of Buckhannon Director of Public Works, will serve as the City's representative in the execution of this Agreement.
- WVWC will provide access as required by the City's Director of Public Works or his designee upon demand. The City and its representatives shall maintain the confidentiality and security of WVWC's space and any records or other property located therein or thereupon.

5) WVWC shall indemnify and hold harmless the City of Buckhannon for any damage, loss, or liability of any kind whatsoever accruing upon the Facility caused or proximately caused by WVWC, its employees, officers, agents, or invitees. WVWC shall maintain its own policies of insurance upon the Facility, and shall name the City of Buckhannon and the as an additional insured. WVWC shall tender to the City a Certificate of Insurance demonstrating compliance with this section prior to its occupancy of the Facility.

6) WVWC agrees to comply with all applicable licensing, zoning, or other ordinances or policies of the City of Buckhannon as an express condition of its occupancy of the Facility.

September 8, 2021, BUCKHANNON, WV: City Horticulturist, Dixie (Green) Dawson, is the person we look to for the annual additions of flowers to our parks, streets, light poles, bridges, planters, and pretty much anywhere she can find healthy soil or hang a basket! But, as is said, "to every thing there is a season."

This week, Dixie has been working to remove the failing flowers and greenery, much of it stifled by a much hotter and dryer August. She and her crew are preparing the flower beds for the Fall and Winter seasons. All of the vegetation removed is taken to a compost pile that is tended to throughout the year, and it is repurposed as a fertilizer for future beds. - **F.1** Approval to Accept the Results of the On-Call Engineering Firm Action taken earlier in the meeting.
- F.2 Approval to Accept Bid Opening Results for One (1) New Articulating Wheel Loader (Street Department) Action taken earlier in the meeting.
- F.3 Approval to Hire Part-Time Technology Internship from Fred W. Eberle Technical Center for SYCC Action taken earlier in the meeting.
- F.4 Approval Event Request-Children's Festival Family Road Trip-Use of Jawbone Park-Modifications due to COVID Action taken earlier in the meeting.
- F.5 Discussion/Possible Vote Waste Collection Board Rental Fee for Use of Space at **395 Mudlick Road** - Amby Jenkins explained the following to Council - In December 2020, the Waste Collection Board traded a piece of property located on Upper Pecks Run to Mike Ross. The property was appraised a few years ago for \$35,000. The City of Buckhannon was purchasing the property at 395 Mud lick Road in the amount of \$1,500,000 from Mike Ross. The property at 395 Mudlick Road was to be shared by both the Street Department and Waste Collection Departments. The trade to Mike Ross reduced the amount borrowed by the City of Buckhannon by \$35,000. In exchange for the \$35,000, the Waste Collection Board would receive 6 months of rent/lease. There has not been any set amount of rent to be paid by the Waste Collection Board to the City of Buckhannon. The City currently pays: \$9,775.00 per month to First Community Bank; \$1,000.00 approximately in utility bills and insurance, which equals \$10,775.00 per month. Note that the Upshur County Health Department pays \$500.00 per month for use of office space at the facility. Mr. Arnold estimates that Waste Collection uses approximately 30% of the facility. \$36,000 per year would be 28%. Noting that the Waste Department is not currently in a strong financial position, it is being proposed that we set the rent for the Waste Department at \$2,000 a month beginning January 1, 2021 using the \$35,000 as a pre-payment, with the monthly payments to come of that amount.

Motion to set the Waste Collection Board rental fee for use of space at 395 Mudlick Road at \$2,000 a month beginning January 1, 2021, using the \$35,000 credit from the Ross/Waste Collection Board Property trade as a pre-payment, with the monthly payments to come of that amount first was made by Thomas/Rylands. Motion carried.

F.9 Approval iWorQ Systems Inc. Software Upgrade - Without objection, the Mayor moved *F.9 Approval iWorQ Systems Inc. Software Upgrade* to the table for discussion and possible vote. Amby and Jerry together presented the following:

IWORQ software upgrade.

We currently use this cloud based module for work orders for our departments (bulky goods, yard debris, maintenance and repairs).

We also use it for citizen's engagement, where citizens can send us messages for various questions and issues.

Amby has been looking for a software to better serve and organize our code enforcement activities. Currently we use excel sheets and notes and word documents.

Jerry has also been looking for software to manage and track assets such as the maintenance of sidewalks, storm water, facilities, and infrastructure.

We have been using IWORQ for several years for work orders. The Water Department recently added backflow maintenance and just started using the work orders for inventory tracking.

Employees can access this from anywhere with a username and password on any computer, tablet or mobile device.

The code enforcement modules total \$5,000 per year, the remaining modules (including those we already have) total \$11,844 which would be divided four ways (general fund, water, sanitary, waste). They have waived the \$14,850 setup fee.

Jerry has also requested a one-time service in which IWORQ would send staff to GPS data points such as signs and use a high resolution camera to assess pavement conditions. The cost of this is \$1,352. They discounted the cost by \$10,000 if we purchase over \$10,000 in software.

Motion to approve the iWorQ Systems Inc. software upgrade was made by Sanders Sines. Motion carried. (IWORQ Services Agreement indexed as City Agreement A318).

F.8 Approval Financial Statement 06/30/2021 - Without objection, the Mayor moved *F.8 Approval Financial Statement 06/30/2021* to the table for discussion and possible vote. Amby present the following Financial Statement 06/30/2021:

Per WV Code 8-13-23, the City is required to prepare a financial statement for the General Fund and Coal Tax Fund within 90 days of the beginning of the fiscal year.

Our contracted CPA-Richard Trent prepares the financial statement for the City.

Highlights of the General Fund financial statement.

On the Balance Sheet:

Under Assets the Cash ending 6/30/21 \$1,306,719 -This was due in part to the infusion of funds from the sales tax fund and the \$830,000 received from CARES funds and \$6,700 reimbursement from Upshur County for Covid supplies. Last year the cash balance was \$570,974

That also reflects in the Statement of Revenues and Expenditures.

Revenues totaled \$5,831,796. Other revenues to note \$113,000 received from Mt Heart for SYCC, Grants for FEMA generators, Gateway sidewalk & lighting project, theatre grant, volunteer grant. Compared to the previous fiscal year other revenues that were down was hotel-motel, B&O, gas & oil severance tax, police fines and court costs, franchise fees and donations. The Public Safety Complex surcharge was eliminated (Apr 2020) in the previous fiscal year and the PRO officer was eliminated from Academy School, so neither of these were collected in fiscal year ending 6/30/21.

Expenditures totaled \$5,003,569. Compared to the previous fiscal year there were \$900,304 more expensed.

Several capital expenditures were made:

Mudlick Road property with three large buildings was financed. The property was purchased for \$1,500,000. The payment for this is \$9775 per month-\$117.300 annual.

65 E Main St (Pythias property) was purchased for \$145,000 (purchased in May)

Fiori Concrete Truck \$179,000

New Lease vehicles -2 Dodge Ram 2500 trucks Flipscreen mesh \$11,780 (dirt sifter)

Three 2020 Ford Interceptor cruisers. Note that three -2013 Ford Interceptors were turned in to sell as trade-ins for the new cruisers.

11 car cams and 11 body cams for the police department were financed.

Police dog (Erros) \$9,000.

Paving of Smithfield Street \$56,000.

And even though it was not in the fiscal year ending 6/30/21, other items added to the depreciation schedule from Jan 2021 to March 2021 Gateway West (sidewalk, lights, storm drain) \$161,127, Paving of Apothecary Lane, Jawbone Park, UCDA access road (get total)

About \$2.5 million in assets was added to assets in buildings, equipment and infrastructure.

The certification of the financial statement will need to be signed by the Mayor, Recorder and at least two members of City Council. Then I will need to publish the financial statement as a Class I legal advertisement.
