F. Strategic Issues for Discussion and/or Vote

F.1 Continued Discussion to Develop suggestions to be made available to property owners on the appearance and maintenance of structures deemed Historic in nature - The members had a discussion regarding both F.1 and F.2 and how best we could discuss Residential Design Criteria Guidelines with the property owners that it would affect. Mr. Smith mentioned that simply implementing guidelines could be difficult. Commission member Kolenich led a discussion concerning hosting a public meeting and inviting all Buckhannon Historic District property owners attend to discuss the idea of developing Residential Design Criteria Guidelines and find out from those property owners what type of guidelines they would be in favor of. Mr. Tenney noted that the state can provide resources, perhaps a person who could attend the public meeting and help facilitate the gathering. He also discussed the need for better education on the residences that are located in the Buckhannon Historic District, especially those properties that are part of the National Registry. Commission member O'Brien noted that we had originally suggested a public meeting like this in February but that we should first check on the availability of someone from that State that could attend and then set the date for the public meeting. Board member Boso noted that she knows of people who would welcome this type of advice along with ideas of available grants for historic residences. Mrs. Kolenich mentioned that we (HLC) have a Facebook page where we could start posting information to build interest. Mr. Tenney also suggested that we add something to the City website regarding the Historic Landmarks Commission.

The members discussed various properties in the Buckhannon Historic District and resources for finding information regarding homes in the district. Also discussed were the possibility of property owners hosting tours of historic homes.

It was determined that Commission Member Kolenich will contact the State Historic Preservation Office and/or Susan Pierce, Director and State Historic Preservation Officer, to schedule a representative who would attend a gathering the we, the Buckhannon HLC, will host, inviting owners of residences in the Buckhannon Historic District and others who are interested in the same, sometime in February or March of 2022. At this gathering we will determine the amount of interest there is for Residential Design Criteria Guidelines for the Buckhannon Historic District.
