The Commission members would like to know if it is possible for the public to view the dog park camera in real time. They think this would promote the park and the public would enjoy watching the dogs in the park.


Commission Members Linger and Critchfield will reach out to news media to report on the dog park in Buckhannon.

#### F. Board Members Comments and Announcements:

Mrs. Jenkins submitted a picture that was sent to them today regarding the feral cat colony at the Walk Trail. Someone has placed a small tent covering over an area where the cats are being fed.



The group discussed the issue. Mr. Teets reported there are some cat colonies in other areas of town. People are feeding the cats. This is in conflict with city ordinances and causes people to dump more cats in the areas. Ms. Linger brought up thoughts of a catch, vaccinate and release program.

Mrs. Jenkins stated that City Council would have to approve any changes to the ordinances, but wanted the group to be aware of the complaint that City Council may have to address.

Ms. Linger updated the group briefly on an animal abuse issue that is being presented to the Upshur County Prosecutor.

She also reported on violation of ordinance in the Cleveland Avenue area. Dogs are being tied out and neglected and of a dog that was injured and neglected, nearly dying from the wounds. Concerned citizens got medical attention for the animal, which is now doing well.

There being no further business to be transacted, meeting adjourned at 5:55.
