

There was also a mention about possible Mothman and Braxton County Monster events.

There has been some soliciting of sponsorships for the basement dressing rooms.

### E.3 Other:

# F. Strategic Issues for Discussion and /or Vote:

### F.1 CAC Programming Policy Revisions:

There are some programming policy revisions to consider. City Attorney-O'Neill did some work on the policy which mostly entailed use of space by other entities.

Other items discussed:

- The proposed drafted programming policy had some rates in it that were originally discussed. There may be need to adjust these rates
- The programming policy talks about a rental review committee
- Under "C" of programing policy is felt to be subjective language
- Section 2-a submission of applications
- Section D mentions operating guidelines and those need to be established
- The rental agreement also should include assuming of liability if city equipment is damaged
- If outside entities are providing their own technical people then there should be qualifications established

It would be helpful if City Attorney O'Neill could attend the next meeting to help with refining the policies.

Amby will ask Attorney O'Neill to contact Erika to go over some of the questions that came up.

Board Chair-Waltz would like to try to have goals by the next meeting to establish goals.

- Determine what would be expected of a consultant
- Define the roles of the Board vs the roles of the Manager and clarify associated supervision
- Help clarify the vision and the use of the CAC for the community use vs professional venue
- Provide training in the area of arts administration, house management and booking, (Direct training to the Manager)
- Create a calendar of simple goals and milestones for the first 30 to 120 days and provide this information to City Council
- Creation of an operations manual

Board Member Buchanan feels there should be a formalized fund-raising goals. This would be a good topic for the next meeting.
