A. Call to Order - The meeting was called to order by the President of the Planning Commission, Dr. Susan Aloï, who asked for all to observe a Moment of Silence. Kelley Tierney led the group in the Pledge to the Flag of the United States of America.

B. Recognized Guests

B.1 Upshur County Development Authority-Executive Director Jennifer M. Tanner-Bostian:
RE: E1 Discussion on Economic Development Section of the 2025 Comprehensive Plan

Dr. Aloï recognized UCDA Executive Director Jennifer M. Tanner-Bostian who noted that she recently presented a full overview of the Upshur County Development Authority (UCDA) 2022-2027 Strategic Plan to City Council (a copy of which is in our meeting packet). Throughout her presentation she also referenced a recent survey of stakeholders that the UCDA conducted.

It was noted that the UCDA purpose is to serve as the City of Buckhannon's & Upshur County's point of contact for economic development services and functions as well as development and marketing of available commercial/industrial properties to capture opportunities.

Ms. Bostian noted that the UCDA is specifically focusing on:

- Working with stakeholders to raise the workforce participation rate.
- Promoting and assisting in developing quality of life opportunities in Upshur County such as housing, the downtown district, general retail, service industries, and outdoor recreation to attract more residents, remote workers, and new employees for existing businesses.
- Educating stakeholders to identify and act on new opportunities for expansion & recruitment through coordination and education of economic development tools.
- Focus on business retention and expansion activities with regular employer interviews and follow up activities.
- Having additional ready properties to capture opportunities for investment as they arise.
- Keep a scorecard of metrics to show economic development progress and areas to improve.

A few takeaways from the survey included:

- 65% of survey respondents said that educational opportunities was an important factor in our community;
- 70% of new jobs come from existing businesses;
- We need more marketing and communication efforts;
- 4,000 nonresidents come in to Upshur County for work daily while 3,000 of our residents leave Upshur County for work daily.

A brief Q & A with Ms. Bostian followed along with comments from various Commission members and Mayor Robbie Skinner.

B.2 City Attorney-Tom O'Neill - RE: E.2 Discussion/Possible Action Recommendation to City Council to Amend Zoning Ordinance No. 244 Section 502, R 2, General Residential District A, to include Condominiums per City Attorney Tom O'Neill

Dr. Aloï next recognized City Attorney, Tom O'Neill who discussed the fact that our zoning ordinance established multiple residential, commercial, and other zones to manage and promote the development of land within the municipal limits. The R-2 zone was established to promote higher density residential construction than is permitted in the R-1 Single Family Residential District Zone. It was noted that condominium or other unit property are authorized in Chapter 36A of the West Virginia Code yet the establishment of condominium or unit properties are not explicitly addressed within the city's zoning ordinance.

Several Commission members asked questions and sought clarifications before the Chair asked for a motion to move the item forward.

Motion that the Planning Commission of the City of Buckhannon specifically recommend to the City Council of Buckhannon to amend Zoning Ordinance No. 244 Section 502, R 2, General Residential District A, to include the placement of condominiums or other unit property, as defined in Chapter 36A of the West Virginia Code, was made by Rylands/Tierney. Motion carried.

President Aloï asked for an update on the Parks & Recreation Board with City Attorney O'Neill and Mayor Skinner explaining that the Ordinance No. 456 of the City of Buckhannon, an ordinance establishing the Buckhannon Parks and Recreation Advisory Board, is up for its second and final reading at the next Council Meeting. Discussion took place.

Mayor Skinner opened the meeting with a brief overview of the purpose of this meeting which is to see what is expected of our parks and if there is the need to hire a Parks and Recreation Director to oversee and develop programming for the parks.

Skinner turned the meeting over to Planning Commission President Dr. Susan Aloï.

Dr. Aloï explained the purpose of the Planning Commission. "The Planning Commission is charged with a development of a comprehensive plan that was then submitted to City Council who approved. There is a section in the plan required by state code regarding recreation. We also completed a survey in the community and received over 750 responses of what people would like to see in Buckhannon."

Aloï noted that many of the responses mentioned recreation and therefore, a Parks and Recreation Subcommittee was developed. Curtis Wilkerson is the chairman of the subcommittee and a member of the Planning Commission. Wilkerson verbalized, "One of the things we did was to assess the facilities and take pictures. The next thing we looked at was the utilization. We started to come to the conclusion that we have all these really great assets but a lack of focus and planning across multiple generations and activities. We wanted to take a look at long term plans of what the City of Buckhannon could be. The parks fall under the streets department, which is already overworked, and our parks are not at the top of the list and there are a lot of street and other city infrastructure that need attention. We haven't had a constant set of eyes on our parks. There are picnic tables with tree limbs falling down on them, unusable horseshoe pits and roofs that need repair." Pictures were also available of our local parks and the areas that need addressed.





Council member CJ Rylands noted when referring to our parks, “This has been a reactive rather than a proactive approach. We want to diminish the load on the street department so they can accomplish their mission and at the same time enhance our parks to improve the quality of life for our citizens. We also want to increase the utilization.”

C. Comments:

Comments were made by many of the participants of the meeting including but not limited to the following:

- Alois- Central Planning will improve use of parks. Example pictures of other communities were displayed.
- Wilkerson- Parks are a quality of life and help keep a community vibrant. Activities go in and out of fashion. Constant planning is important.
- Rylands- If a Director would be hired the framework to develop that position should be thought out.
- Sines- Questioned if the position should be a director or a worker. What would a director do during the winter? There is a lot to consider.
- Thomas- Wants to be proactive. More things are possible with the help of sales tax revenue. This needs to be looked at in total, along with Stockert, Colonial, the Madison/Jawbone, Dog Park and

trails. Maybe we need less parks. This should be reviewed comprehensively. Maybe one person to look at all these facilities every day.

- Reger- Suggests forming a committee to develop a plan over the next year.
- Skinner- Some of the parks are used in different ways. Madison/Jawbone is more for events, city parks are combination of youth and adult activities. Some parks are more aesthetical.
- Clemens- Lives next to the City Park on Park St and observes it. It is maintained and well mowed during the spring and summer season and a little less during off season. It is well used. There doesn't need to be a formal program every week.
- Jerry Arnold- Cautioned that if a Director were to be hired, not to set them up for failure. Directors working for the city do more than just organize and manage, they must help with the daily tasks as well. A few part time personnel will not be beneficial to help a director that has been described.
- Mr. Carl Weaver was present and acknowledged for his hard work the past year in working as a park attendant. Weaver spoke of issues, including homeless people and drug issues in parks as well. Additionally, Weaver noted it is not an easy task and would require a team of people to effectively run and improve our present parks.
- Dr. Reed expressed his own observations, stating that West Virginia Wesleyan College is Buckhannon's largest attraction. In addition, he made request to council to consider remodeling Jawbone Park and having adequate restrooms available.
- Former Mayor David McCauley spoke on the issue, stating, "We need to focus on accessibility and inclusivity." He also noted that he would recommend a full-time director to promote planning and work on funding. Furthermore, McCauley said working on "inter-connectedness" of our parks and recreation system would be beneficial.
- Comments in favor of a park director came from a few guests that were present virtually and in-person. Others would like to see more volunteerism to help. There was much discussion on what would be most beneficial to all departments and individuals when developing a plan to improve our parks. All in attendance discussed pros and cons of various options. Initially it was discussed to have only a part-time director to oversee our parks, however it was pointed out by others in attendance that in the off-season would be the time that would be spent to plan for the next open season, make significant repairs and perform grant writing to provide funding to improve the recreational areas in Buckhannon. Parks are generally in-season starting in May and closing for off-season in October. Discussion also explored increasing volunteerism to address repairs such as group painting projects.

Overall, it was noted that the City of Buckhannon is highly ambitious to develop and implement a plan to improve our recreational areas. Multiple ideas were also considered including exploring opportunities to fund creating a skate park, splash pad, pickle ball, ice rink and sled riding areas. City Council mentioned possibly using sales tax to cover costs of projects but other funding would still be required. It was also reported that grants may be available to the city for recreational projects. What's more is that the consensus was that more utilization in our parks improves quality of life for our citizens and will also deter drug use and vandalism.

Upon the end of discussion, Mayor Skinner noted that he would recommend that City Council create a Parks and Recreation Board, appoint members and move forward. “I think this is a great first step. We will explore the quick tangibles that we can achieve, then mid-range line items we want to tackle and then long-range end of the road planning of what we want to see happen with the parks,” Mayor Skinner concluded.

D. Adjournment: There being no further discussions, the meeting adjourned at 8:54 pm.

E.1 Discussion on Economic Development Section of the 2025 Comprehensive Plan –
President Aloï reviewed the Status of Goals from the Comprehensive Plan with the Commission. One item discussed was the tourism element of the City and there was interest in having the CVB office open on the weekends when visitors are in the downtown area. A more in depth discussion took place concerning businesses opening on weekends as well. Recorder Sanders provided an overview on his experiences as the City’s representative on the Board for the CVB and noted that the CVB’s primary function is to create and implement marketing programs for outside areas like Pittsburgh and Washington, DC. He is willing to address the question about having weekend hours and an upcoming CVB Board of Directors meeting.

Commission member Rich Clemens suggested having an alternate space for people to pick up information on the weekends. Also, instead of asking our people why they don’t want to work weekend, instead research with community’s that already have weekend hours to find how they do it.
