Two candidates are currently on the eligibility list:

1.HATHAWAY, ANDREW DEWAYNE 72.41% 2.HAYMOND. MICHAEL ALLEN 80.11% Upon review of each of the new applications that were submitted, it was noted that one application, Brian Acha Fondem was rejected as the candidate was not a United States Citizen. The Buckhannon Police Civil Service Commission follows the WV Code requiring US Citizenship.

It was also noted that three of the new application candidates either had past employment as a law enforcement officer or is currently employed as a law enforcement officer.

• Bender is a currently employed law enforcement officer and would not be required to take the P.A.T. test as he could be eligible for a lateral transfer. However, he would be required to take the written test.

The other two candidates (Warner and Kelley) will be required to take the P.A.T. test and written test as they are not current, actively employed in law enforcement as of this date.

- Warner is not a current, actively employed law enforcement officer since August 2024 and was employed in Texas
- Kelley is not a current, actively employed law enforcement officer since 2018 and was employed in New Jersey.

Motion Kolenich/Spencer to authorize that the applicants excluding Brian Acha Fondem, can move on to the next phase of testing. Motion carried.
